3. A presentation from YMAS regarding the First Responders' Scheme was given. A cheque from 1000 was then presented by Silsden Town Council for the training of Silsden volunteers
4. POLICING & CRAVEN TASKING GROUP UPDATE – No update Cllr Trainor was asked to take back to the tasking groups the following issues which were causing concern- Anti social behaviour in the MUGA, youth disturbance in the Aireview area and a request for more Bobbies on the beat akin to the move North Yorkshire have made in this direction. The clerk was also asked to write to WYP, Anne Cryer and the Government on the last issue.
